1. General comments

This study visit report was prepared within the EU Twinning Project" Further Support to the Reform of the Statistics System in Bosnia and Herzegovina" and organised under Component 1, Subcomponent 1.1. Statistical Business Register, Activity 1.1S.

2. Lessons Learned

The study visit program was carefully designed and made to address the main concerns related to the implementation of EG in the Statistical Business Register of Bosnia and Herzegovina.

The program included a series of presentations and in-depth discussions that focused on relevant practical issues.

We are pleased to report that every scheduled topic was successfully covered, providing valuable insights and knowledge to all participants."

The study visit program included presentations regarding the implementation of EG in the Finland Statistical Business Register. The following topics were particularly discussed:

- 1. Enterprise Groups register in Finland
- 2. Enterprise groups register application
- 3. Euro Groups register, interplay with national register and Eurostat EGR

- 4. Statistical Unit Enterprise in Finland
- 5. The Finnish Real-Time Economy project

The first day of the study visit was dedicated to Enterprise Groups register in Finland as well as the Enterprise Groups register application.

The Finnish experts have provided a comprehensive explanation of the significance of Enterprise Groups and the EG Registry. An overview of Enterprise Group updating and data sources were also presented.

We were introduced to various concepts and terms related to enterprise groups, including the global group head (GGH), global decision centre (GDC), multinational enterprise groups (MNEs), truncated enterprise groups (TEGs), foreign-controlled enterprise groups, all-resident enterprise groups, and domestically controlled enterprise groups.

The second day of the study visit, was dedicated to Euro Groups register and Statistical Unit Enterprise in Finland.

On the third day, a very interesting presentation on "The Finnish Real-Time Economy project" was presented by Mr. Mika Lassander. The presentation provided valuable insights and information about this innovative project. The advantages of this project are:

- Services will have moved to the cloud and they will talk to each other.
- Companies will be able to move or share data efficiently and automatically.
- The economy will operate in real-time.
- Financial data will move automatically: key business information, including orders, delivery information, and invoices, will be transmitted automatically between companies.
- Companies will no longer need to dedicate time for their obligations towards the authorities-business data will also be transmitted automatically for purposes such as taxation or compilation of statistics.

3. Conclusions and recommendations

Participating in the study visits has proven to be extremely valuable for the BC statisticians dealing with the Statistical Business Registry and Enterprise Groups.

They gained an extensive knowledge from the theoretical insights shared on various topics. These meetings contributed to better understanding of methodological and practical issues concerning Enterprise Groups.

Considering the ongoing implementation of Enterprise Groups in SBR of Bosnia and Herzegovina, any information gained during this study visit was more than valuable for further work.

The presentations of Finish experts, emphasised the importance of the implementation of Enterprise Groups in the Statistical Business Registry.

Experience gained from this study visit will be used in the further development of Enterprise Groups in Bosnia and Herzegovina.
